1. Consent To Conduct Background Investigation

As a condition for Robertson County E-911's consideration of this application, I give permission to Robertson County E-911 to investigate my personal and employment history. I understand that this background investigation will include, but not be limited to, verification of all information on this application, as well as interviews with past employers. I further give permission to Robertson County E-911 to conduct this investigation and to discuss the results of this investigation in connection with my application for employment.

2. Consent To Contact Past Employers
