- 1. 911 Director Hope Petersen
 - a. Hope has researched and spoke with Jody Stewart about the It-position with the county. Jody stated that he does work for all the county offices. Also Hope asked Sheriff, Michael Van Dyke about their IT-position. Hope has also reached out to TENA to get information from similar counties, she will get and present at next board meeting. Jason Head suggested we need to have a pay-scale in place before we advertize position. Russell Gupton agreed and stated to get all information together and bring to the next board meeting in February 2019.
